Resolution of the Warwick Sewer Authority

Changes to Sewer Usage Charges

Whereas, in May 2016, the Warwick Sewer Authority's (WSA) rate consultant, B & E Consulting, LLC of Providence, Rhode Island, completed a five-year rate study of WSA's sewer usage charges and fee structure for fiscal years 2017 through 2021;

Whereas, on May 19, 2016, following a public hearing and public comment period, the WSA approved changes to its sewer usage charges for fiscal years 2017 through 2021 (no rate changes were called for in FY2017);

Whereas, B & E Consulting, LLC, conducted its annual review of sewer rates, confirming the approved rates for fiscal years 2018 through 2021;

Whereas, a public hearing was properly noticed and conducted on May 18, 2017, to review the WSA FY2018 budget, corresponding sewer usage charges and planned increase to the Renewal and Replacement charge;

Therefore be it resolved:

The Warwick Sewer Authority hereby approves the following schedule of sewer usage charges:
